Boondoggles

AFP-AZ does not have a means of objectively scoring the impact of local-government boondoggles, including corporate welfare handouts and tax abatements awarded to politically-connected developers, except insofar as those boondoggles increase current operations and capital budgets.

Absence

If an official is absent for all key votes, such is noted in the "Category" column. Officials who are present for at least one key vote receive a score of zero for missed votes, and receive a total score.

**Failed
to Post**

Schedules A & B of the state-required budget reports should be posted on a jurisdiction's website, as well as the minutes for the board/council meetings at which the final budget and final property tax levies are approved by roll call vote. The Category designates failure to post the documents by October. AFPF-Arizona will update past and present scorecards to incorporate missing data, if city officials send us links to Schedules A & B, and to the minutes for the meetings in which the budgets and levies received final approval.

**Note on
Property Levies**

When a property tax levy is less than one percent of a district's budget, the levy is dropped from the scoring rubric.

**Note on Lean
Government Bonus**

CY 2015 is the first year the Local Government Scorecard includes the lean government bonus point. The bonus point is awarded to three categories of municipalities that have the leanest government (top 20% for each category), defined as the total 2015 budget amount divided by the most recent estimated population. The three types of municipalities for the lean government bonus are: cities under 50,000 in population, cities over 50,000 in population, and all Arizona counties.
